### **About**

Cahoots Live! is the performance stage at the Cahoots Festival of Fun, created to spotlight the talents of people with disability and those facing exceptional circumstances.

We are inviting performers to apply for one of the stage spots across the day. Each act will have up to 10 minutes to perform. You can take the stage solo or as part of a group of up to five people.

Whether you love to sing, dance, play music, perform comedy, share poetry or showcase another talent, this is your chance to step into the spotlight and share what makes you shine in a supportive, inclusive setting.

Applications are exclusively open to people with disability and those facing exceptional circumstances, ensuring this stage is a dedicated space for your voice, creativity and skills to be celebrated.

To be considered, you will need to apply in advance via our application form. The form includes an option to upload a short video of your act so we can get a sense of your performance. We cannot wait to see what you will bring to the Cahoots Live! stage.

### **Cost**

There is no cost to the performer. All costs will be covered by Cahoots.

### **Event Details**

The performances will take place on Saturday 2<sup>nd</sup> May 2026 between 10.30am - 1.30pm. If successful in becoming one of the performers, we will give you an approximate time of performance, but we ask performers to be onsite from 10am – 2pm.

The event will be held at Cahoots Adventure Camp, 100 Kirby Road, Bullsbrook.

### **How to enter**

Applicants must complete the online application form. We recommend attaching a short video to support your entry.

Videos can be uploaded via the online form, or a link shared from a platform such as YouTube or Facebook.

All applications must be submitted by Sunday 5<sup>th</sup> April 2026. All entries will be treated as

### **Cahoots Live! Performance Stage – Festival of Fun**

Cahoots Live! is **not a competition**. No prizes will be awarded. Performers are selected to participate in a live showcase performance only.

There are **nine (9) performance spots available**. Submission of an application does not guarantee selection. Cahoots reserves the right to select performers at its sole discretion.

By submitting an application, you agree to be bound by these Terms and Conditions.

#### **2. Applications and Selection**

- All applications must be submitted in the manner outlined by Cahoots.
- Cahoots reserves the right to accept or decline any application.
- Selection decisions are final and no correspondence will be entered into.
- Cahoots is under no obligation (express or implied) to select any applicant.
- Unsuccessful applicants will not be entitled to compensation or damages.

#### **3. Media, Photography and Promotion**

All photographs and video recordings taken during the event remain the property of Cahoots and/or the event organisers.

By participating, entrants authorise Cahoots and the event organisers to:

- Use their name, image, likeness and performance footage
- Use photographs and video recordings
- Publish content on websites, social media, promotional materials and future marketing campaigns

This use may occur without further notification or compensation.

#### **4. Ownership of Submission Material**

Each applicant retains ownership and copyright of their submitted material.

- That Cahoots may contact them by email or phone regarding their application
- To ensure they have appropriate permission for any music, choreography or material used in their performance
- To comply with event safety requirements and directions from event staff

Participants are responsible for ensuring their performance content is appropriate for a family-friendly event audience.

- Any act or omission by the entrant in connection with the event
